Subject – Permission to operate transshipment of Imported/Export cargo from Air Cargo Complex, Amritsar to Mumbai, Delhi and vice versa in r/o M/s Interglobe Aviation Ltd – reg.

It is notified for information of all concerned that M/s InterGlobe Aviation Ltd., Ground Floor, Central Wing, Thaper House, 124, Janpath, New Delhi-110001, a private airlines operator approved as scheduled Air Transport Operator by DGCA vide Permit No. S-19 dated 03.08.2006 has sought permission for transshipment of Imported/Export cargo from Air Cargo Complex, Amritsar to Mumbai, Delhi and vice-versa

2. M/s InterGlobe Aviation Ltd. has executed a Bond of Rs.50,00,000/- (Fifty Lacs) alongwith Bank Guarantee of Rs. 7,50,000/- (Seven Lakh and Fifty thousand) for transshipment of imported goods and Bond of Rs. 1,00,000,00/- (One crore) alongwith bank guarantee of Rs. 15,00,000/- (Fifteen Lacs) for transshipment of export goods in favour of " the President of India" through Commissioner of Customs, Customs (Preventive) Commissionerate, Amritsar in terms of CBEC Circular No. 56/2000-Cus dated 05.07.2000 for the proper accountal of goods. The amount will be debited from the bond when the transshipment cargo is taken by the Custodian and it will be credited when the proof of handing over the cargo to the Customs at final destination is produced. M/s InterGlobe Aviation Ltd will be responsible for shortage/pilferage of the cargo, If any, and if so, they will be required to pay the amount equal to Customs duty, cess and other levies involved along with applicable interest and penalty.

3. Now, in pursuance of power vested in me under Section 45(1) of the Customs Act,1962 I , Dipak Kumar Gupta, Commissioner of the Customs , Customs (Preventive) Commissionerate, Amritsar hereby accord permission to M/s InterGlobe Aviation Ltd. for transshipment of imported/export cargo from Air Cargo Complex, Amritsar to Mumbai , New Delhi & vice versa.


4. Transshipment of Imported and Export Cargo permitted as per this Public Notice will be governed by:

- (a) The provisions of Chapter VIII of the Customs Act, 1962.
- (b) Goods Imported (Conditions of Transshipment) Regulations, 1995.
- (c) Handling of cargo in Customs Areas Regulations, 2009.

(d) Boards Circular No. 69/99 - Cus dated 06.10.1999 as amended by Boards Circular No. 61/2000-Cus dated 13.07.2000, 78/2001-Cus dated 07.12.2001, 79/2001-Cus dated 07.12.2001, 46/2005 -Cus dated 24.11.2005 and 06/2007-Cus dated 22.01.2007.

(e) Any other Rules, Regulations, Notifications, Instructions, Circulars & Public Notices issued from time to time.

5. The said permission shall be valid till 12.10.2018.


